OVER 100 CONCERNED PHYSICIANS TO ADVISE MEMBERS OF CONGRESS ON HEALTH CARE REFORM

Washington, DC – Congressman Tom Price (R-GA) today announced the following physicians have been selected to serve as consultants to the Physicians' Council for Responsible Reform.
